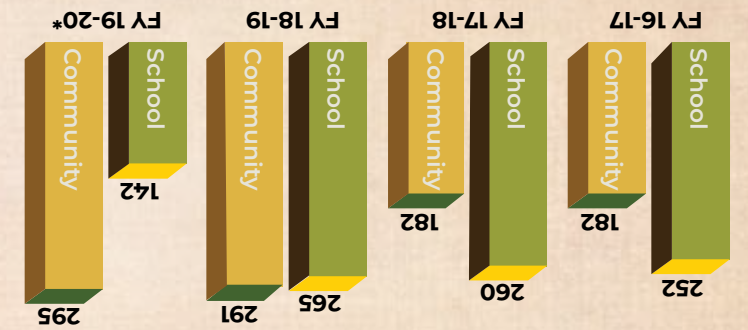

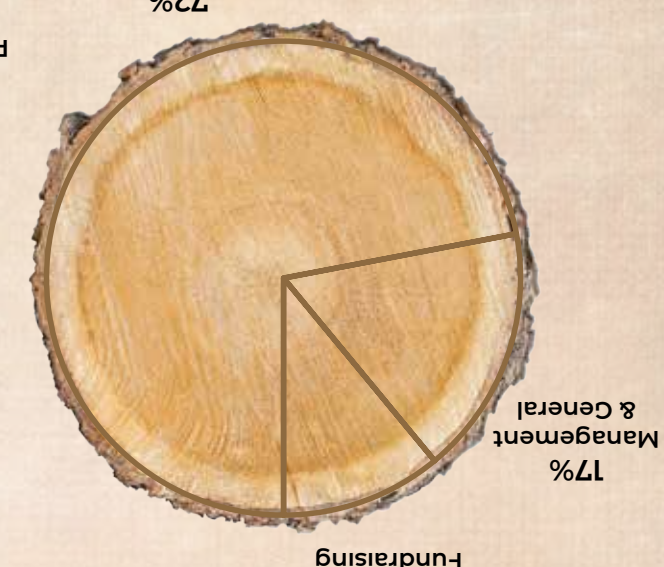

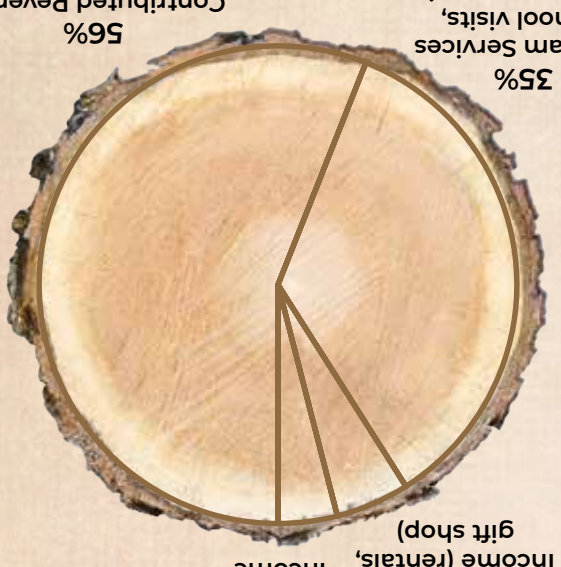

EDUCATIONAL TECHNOLOGY & EQUIPMENT

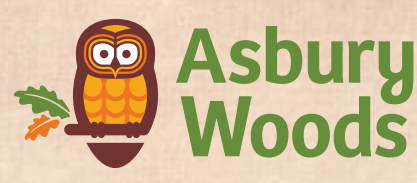


Significant investments to add, upgrade and replace technology capabilities for our school programs to achieve meaningful integration of STEM concepts into our environmental education curriculum.
