Asbury Woods provides weeklong day camp programs for children ages 4-14. The general work schedule for this position is Monday – Friday, 8:00 AM – 4:30 PM.

**Qualifications:**

1. Individuals who are working towards or have obtained a Bachelor's degree in biology, environmental science, education, special education or related field.
2. Experience working with children ages 4-14 in a formal classroom setting or informal setting including day camps, youth programs, sports, etc.
3. Background or strong interest in science, nature, or outdoor recreation.
4. Must complete a first aid, CPR and anaphylaxis and epinephrine auto-injector trainings.
5. State and federal background checks are required for this position.

**Full Job Description:** Nature Camp Counselor

**Performance Responsibilities:**

1. Implement an age-appropriate day camp program for children ages 4-14, including preparing materials, leading activities from the established camp curriculum, and developing camp curriculum.
2. Supervise up to 16 campers including maintaining a safe and positive learning environment, maintaining attendance records, and communicating with parents daily.
3. Maintain supplies needed for day camp programs.
4. Maintain cleanliness and of classroom spaces and equipment used by campers.
5. Ability to work well with volunteer camp assistants.
6. Work with other volunteers, staff and interns in presenting day camp programs.
